Problem

If the city withholding limit is set to a percentage of gross earnings, city withholding continues to be calculated even after the year-to-date earnings for a particular employee have passed the limit.

Solution

The problem is corrected by following the steps listed below.

- 1. Backup the diskette(s) and make the changes on the Backup copy of the program.
- In BASIC load the program by typing LOAD"PR4INPUT"
 Type 629ØREM <ENTER>
- 4. Type DELETE62ØØ-629Ø <ENTER>
- 5. Now enter the following lines.
