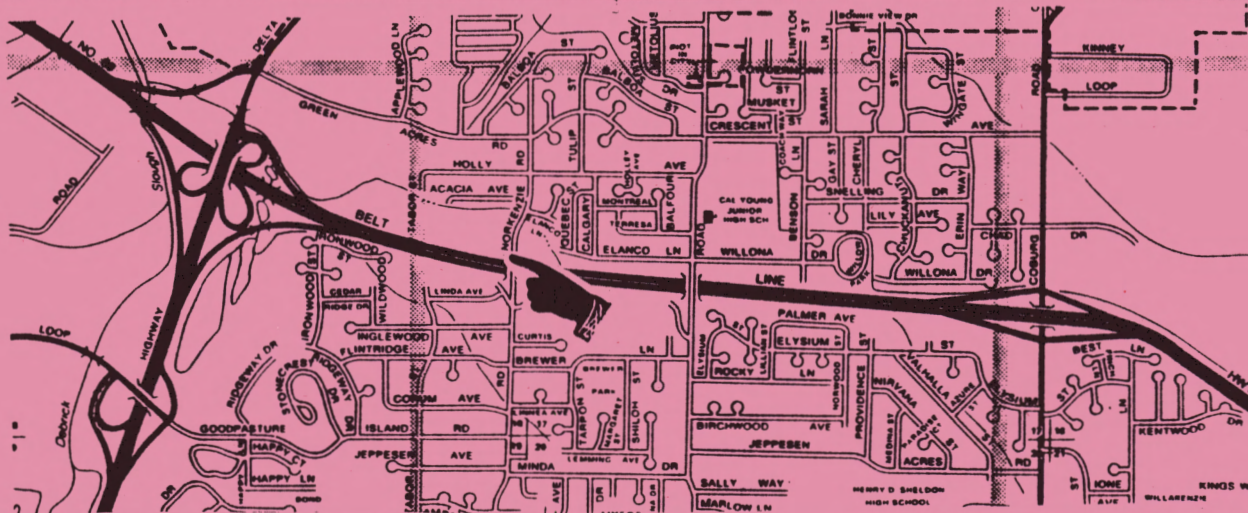


NOTES FROM THE PRESIDENT by Mike Luttio

"No Implied Warranty For Any Purpose..."

The other day I had the opportunity to "get" WordPerfect from a friend's hard drive at work. I knew that I could purchase WordPerfect by mail for about \$200, or pay my local dealer the retail price of \$495. But this was free. What a dilemma.

If I purchased WP by mail and then found out that my Junior didn't like it, what chance would I have sending back the opened package? The salesman down town said about the same thing: open the shrink-wrap and it's your's. (He also said, "What's a Junior?") Lo and behold, my buddy said, "Here, take my back-up copy and try it out. Who knows, it may work just fine on your Junior."

DISKCOMP, DOS's disk comparison program, did indeed show that these copies were identical to my buddy's original disks. In fact, the copies were on Verbatim diskettes and looked even better than the originals. If you removed the labels, it would have been very difficult, if not impossible, to tell which set of disks cost nearly \$500 and which cost \$5.

The scenario just outlined is what is so upsetting to software companies. Everyday, people zap copies of commercially-made software which they use as back-up copies, copies to be "modified" for personal use, and as in this scenario, to give to their friends. It is this "copy for the friend" that has the software companies up in arms. Who knows if the recipient of this pirated copy will just try it out to see if it works? And if it does work, will they ever go out and purchase their own copy after getting one from their friend? The software companies say, "no."

I would guess that most folks who have a computer at home also have a VCR and stereo equipment. Surely, they don't make duplicate tapes of music to play in their automobiles from commercially-made tapes. (Ever been to a garage sale that didn't have some of these tapes for sale?) Have you ever "loaned" a tape of a TV program you recorded to a friend? Or better yet, have you ever loaned a friend your copy of The Clan of the Cave Bear? Ironically, the basis for this article came from a Xeroxed copy of an

article by Jay Kinney that appeared in the Whole Earth Review.

All of this can get pretty hazy. We pay a tax now on blank cassette tapes to compensate record and tape companies for their supposedly lost income. Now we can use our tape recorders with a clear conscience. We can also use our VCR to record programs as long as we don't use these tapes commercially. But we can't use them to duplicate tapes we have rented from the video store. It is still legal to loan a book to your neighbor, but you can't Xerox the book and give the copy to your neighbor. I often wonder about all of those handouts and packets we had to buy at school; they were all copies of books and copyrighted magazine articles. If I read this correctly, my college ethics professor was not committing a crime when she Xeroxed Kinney's article for me, but my buddy committed a crime when he gave me WordPerfect to try.

Life was so easy before Xerox made us all become criminals. Can we say the same for Dale Carnegie? While he sure cut into the sale of books, I have never heard bookstores complain about libraries, and appliance stores don't complain about laundromats. GM allows Hertz to rent cars they have purchased. I just can't believe that Central Point Software Company is guilty of aiding and abetting criminal activity anymore than I can say that Smith and Wesson is responsible for the local bank being robbed. But let's get back to the problem at hand.

Kinney's scenario in his article goes something like this: The bushes outside your window look a little wild, so you decide to trim them. Your old clippers are all rusted out, so you go to the store to buy new ones. You ask the sales person about his latest model and he convinces you that they will do the job. "How much," you ask.

"400 bucks," he replies.

"Wow, what kind of a warranty do they have?"

He says, "The best in the market. The warranty offers absolutely no guarantee that they will perform as described. If you should be dissatisfied with the clippers you cannot get your money back. You cannot legally resell these clippers to anyone else. Actually, the \$400 merely buys you a license to use the clippers on only one hedge. If you have a hedge in front and in the back of your home, you should get two hedge clippers. Should you violate any of the other terms of the warranty contained on the sheet of paper packed inside the clippers, the clipper's ownership will revert back to the manufacturer and you will be liable for prosecution."

You say, "Great! I'll buy them."

After you get home, you open the package and take the clippers outside to try them out. Soon after you start clipping, you hear some strange beeps and the clippers just stop. You go back and read through the 100+ page manual and soon find that there is a glitch. Some of the clippers won't operate on Oregon Grape bushes. You call the technical number listed and after being on hold for 45 minutes listening to Paul Harvey, you find that there is indeed a glitch in this model of the clippers, but they will issue you a "return authorization number" and then you can send them, prepaid, back to the company with your check for \$25, and they will send you the most recent, updated version of the clipper. Of course, it will take 6 to 8 weeks.

Two months later, you are back to clipping. After you finish the job, you put your clippers up and your neighbor drops by. He comments on how well your bushes look compared to his, so you tell him about your new clippers. He then asks to borrow them to see how well they do on his trivet hedge.

You say, "Sorry, but the clipper-owner agreement that went into effect the moment I opened the shrink-wrap says that these clippers can't be used by anyone but me. If I let you use them we'll both be taking food out of the mouths of the

Your neighbor, dumfounded, says, "Wow, sorry I asked. How about if I buy the clippers from you for 5 bucks and then, when I'm through, I'll sell them back to you for \$5. That way, you won't be loaning them in violation of your agreement with Clipper Company."

You reply, "Sorry, but any change in ownership violates the warranty and I'd never be able to get any future updates or technical assistance. Actually, I don't really "own" these clippers, I only have the right to "use" them and that right isn't transferable. Come on, why don't you go out and buy your own pair? They're only \$400."

Is this all farfetched? Well, I don't know. WordPerfect worked well on my Junior, and I still haven't purchased my own copy. Now, 5.0 is out. Again, I have the dilemma. I know I can't afford to purchase a \$400 program, and I am not sure that I am a prospective customer even at \$200. Writing Assistant still does most of the things we need for this newsletter, but...

I encourage everyone to stop and go read the license agreement on the cover of their DOS manual or other commercially-made software. Just the wording makes you a little irritable!

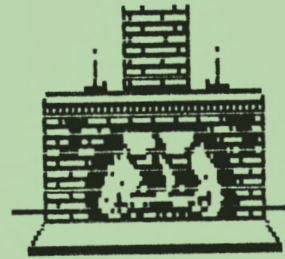
How was your Thanksgiving holiday? Mine had an interesting "turn" of events.

Q: My kid seems to have her computer on every time I go by her room. Just how much does it cost me for her to have that thing on all the time?

Al in Sacramento

A: It's always good to hear from you, Al. For your answer, I'm going to quote from the Eugene Register-Guard newspaper where they say, "It comes close to a nickel a day at the average Oregon electric rate of 4 cents per kilowatt-hour (kwh)."

"Actual energy use will vary with make and model of computer. In general, a home computer system used eight hours a day, five days a week will cost \$1.07 per month to operate at 4 cents per kwh.

"This assumes the system consists of a processor, video display terminal and printer, which together cost about 6 cents an hour to operate.

"The power used by the components breaks down this way: processor, 30 watts; video display terminal, 45 watts; and printer, 75 watts. This adds up to 150 watts, the same amount of power used by two 75-watt light bulbs."

Quicksoft has delivered the Club's copy of their new PC-WRITE. On The Medical Front

Warning to computer freaks: excessive preoccupation with your machine can reveal a dormant psychosis, report doctors in Denmark's Weekly Journal for Doctors.

One Danish 18-year-old was so absorbed that he neglected his friends and spent 12 to 16 hours a day at his home computer. "He merged with it," say psychiatrists Eva Jensen and Erik Simonsen and psychologist Bent Brok. He began to think in computer-programming language, suffered from insomnia and anxiety and finally was unable to distinguish between his programs and the real world. He had to be hospitalized and treated for psychotic illness.

The computer trade itself recognizes the problem. Lars Knudsen, director of a high-technology information agency, estimates there are 5000 computer freaks in Denmark. Typically, they are between 12 and 18, and 95 percent of them are boys. They sleep into the afternoon and then sit in front of the screen until four in the morning. As their preoccupation grows, the always rational computer becomes a substitute for human contact.

Q: I did an interview for a class I am taking which took three appointments to complete. I transcribed these three interviews each day, and saved them to disk as INT1.DOC, INT2.DOC and INT3.DOC. Is there a way that I can combine these three files into one?

A: DOS has all the answers! You can do this chore two ways. One would be to type `COPY INT1.DOC+INT2.DOC+INT3.DOC INT.DOC`. The new file, INT.DOC is now one file containing all the data of 1, 2 and 3. This format is usually shown as [file1]+[file2]+[file3] [newfile]. Of course if these were the only files with the extension DOC on the disk, a simpler way would be to type `COPY *.DOC INT.DOC` (or any name you wish the final file to be).
